Bids will be opened thereupon or about 3:00 p.m. EST, November 1, 2022 at a public bid opening at DBCAA, 1535 Shamrock Road, Manchester, KY. Bids must be received by the designated date and time and none will be considered thereafter.

ELECTRONIC BIDS: Electronic Bids will also be accepted for this project. Bids must be signed and submitted in the same required format. Submit one (1) electronic copy via email to Ashley.Sandlin@DanielBooneCAA.org. After sending your bid, Bidders are encouraged to verify the successful delivery of the document. Bids must be received by the designated date and time and none will be considered thereafter.

Pre Bid Meeting:

A pre-bid meeting will be held on October 13, 2022 at 11:30 AM EST. All bidders must meet at DBCAA, 1535 Shamrock Road, Manchester, KY 40962. Participation is not mandatory but highly recommended. Participants will be given the opportunity to inspect the property and view the parking lots to make an accurate estimate of the repair costs.

Bidders must submit their bid in a sealed envelope, and the bidder is advised to clearly mark the sealed bid with the bid number and description, opening time and date listed above. DBCAA is not responsible for the premature opening of, or the failure to open, a sealed bid not properly addressed or identified.
